#### 1. DO NOT PRINT ON BOTH SIDES OF THE PAPER ON ANY FORM

- Use the attached modification petition.
- Print a Criminal Record/Abuse History Verification from <a href="www.eriecountypa.gov/courts/family-court/custody-conciliation">www.eriecountypa.gov/courts/family-court/custody-conciliation</a>.
- For each of the above forms: fill in the blanks and make three (3) photocopies of **both** original forms for <u>a total of four (4)</u> of your completed paperwork (you will need one (1) additional copy per additional party <u>if</u> more than two (2) parties are involved with your custody case).
- **2.** Submit in person <u>or</u> mail all original forms and copies as stated above, along with one (1) additional blank Criminal Record/Abuse History Verification form for each defendant/s and a money order or check (payable to Prothonotary) for the **modification fee**. For in person submissions, cash or credit/debit card are acceptable **DO NOT MAIL CASH**. Call 814-451-6234 for current fee.

One (1) certified copy is to be served on the other party/ies by regular first class mail. You must complete a Certificate of Service for the regular first class mail and provide it to the Custody Conciliation Office.
